MNR has reviewed the modifications to the Natural Heritage section of the Environmental Effects Monitoring Plan (EEMP) for the Bluewater Wind Energy Centre located in Huron County, submitted in August 2013. The final document is titled Natural Heritage Environmental Effects Monitoring Plan (EEMP) for the Bluewater Wind Energy Centre and dated August 2013.

This letter confirms that the EEMP was prepared in respect of birds and bats in accordance with the Ministry of Natural Resources:

- Birds and Bird Habitats: Guidelines for Wind Power Projects (2011)
- Bats and Bat Habitats: Guidelines for Wind Power Projects (2010 and 2011)

Post-construction monitoring for the Bluewater Wind Energy Centre will include the following:

- Bird and Bat mortality monitoring at a minimum of 11 of 37 constructed turbines
- Bat Maternity Colony (features BMC-01, BMC-07, BMC-08, BMC-13)
- Red-headed Woodpecker Habitat (feature SCB-02)
- Amphibian Woodland Breeding Habitat (feature AWO-11)
- Amphibian Wetland Breeding Habitat (feature AWE-01)

If, based on results of pre-construction monitoring, wildlife habitats are found to be significant the following post-construction monitoring will also be implemented:

• Amphibian Woodland Breeding Habitat (feature AWO-13)

An additional post-construction commitment has been made to compensate for the loss of up to 0.5ha of woodlands. Details of the afforestation plan will be prepared in consultation with MNR.

MNR expects the information contained in the natural heritage section of the EEMP to be implemented by the applicant.
